We are expecting anywhere between 500 to 1,000 guests to join in on the festivities. We are looking for a broad spectrum of arts, crafts and entertainment services to represent Florida's talented artists. The artist fee is \$60 and includes a 10x10 booth space. The fee is good for one artist. If additional artists or guests are assisting you each person must pay an additional \$60. Primitive camping is available to them at that price

We will notify the selected artists by October 10th, 2020. Upon notification of acceptance we will require payment for your space in full by October 15th, 2020. Once accepted and payment is made no refunds will be available. Your accepted application is a commitment to exhibit.

Artists are requested to be set up and open for display by 11:00am on Friday. Location is at the vendor coordinator's discretion. Saturday, artists are asked to have their booth set up for exhibit during peak festival hours. Sunday, vendors may pack up any time after noon at their discretion.

Artists may leave displays up overnight however; Monster Mash Festival or Lone Palm Ranch will not be liable for any loss or damages from any occurring circumstance. The security and protection of your exhibit area and your art or craft is your sole responsibility.

Artist is responsible to collect and report sales tax according to law on any items sold.

Artist acknowledges and agrees that Monster Mash Festival does not guarantee weather conditions or guest numbers and shall not be liable for loss or damages of any type due to partial or complete cancellation of the event. Monster Mash Festival is in no way responsible for merchandise or equipment damage, personal injury or property damage at the event. Artist agrees to comply with requirements listed within this application.
